This is noted that the essential qualification for admission to M.Sc. in Geography is as under (Annexure-I) -

'B.Sc./Bachelor degree with Geography as one of the subjects/Shastri examination (new Scheme) of three-year duration with at least of 50% (47:5% marks for SC/ST/Blind/Visually and differently abled candidates of Haryana only) marks in aggregate, or any other examination recognized by Indira Gandhi University. Meerpur, as equivalent thereto.'

Last year, this qualification confused students as well as admissions authorities. So, there is a need for rectification in the essential qualification for admission to the M.Sc. in Geography.

The committee has recommended the following eligibility conditions for admission in M.Sc.
