महाविद्यालय के कुलपित डा सत्यपाल सुलोदिया ने बताया की किसी लड़की को बिना उसकी मर्जी के गंदी नीयत से छूना, गंदी मैसेज भेजना, जबरदस्ती किस करना, गंदी बातें करना, लड़की को देखकर भद्दी टिप्पणी करना, सीटी बजाना, उसकी सेक्सुअल लाइफ के बारे में जानने की कोशिश करना और फोन पर या सामने उससे भद्दे मजाक करना ये सारी बातें सेक्सुअल हैरेसमेंट में आती हैं। किसी भी तरह की यौन गतिविधि जिसमें आपकी सहमति न हो, उसको यौन उत्पीड़न कहा जाता है। यह पूर्ण रूप से

आपकी इच्छा के विरुद्ध की गई यौन गतिविधि होती है। इसमें आपके साथ किसी भी तरह के शारीरिक संपर्क बनाए जाने को शामिल किया जाता है। यह न सिर्फ महिलाओं, बल्कि बच्चों और पुरुषों के साथ भी हो सकता है। यौन उत्पीड़न के कई प्रकार होते हैं, जिसमें कई तरह की गतिविधियों को शामिल किया जाता है।

डॉ सतीश सैनी ने बताया कि यौन उत्पीड़न का शिकार हुए व्यक्ति को विशेष तरह की सहायता की आवश्यकता होती है, जिसमें उनका परिवार अहम भूमिका निभाता है। महिला प्रकोष्ठ अधिकारी डॉ पलक द्वारा छात्राओं को कॉलेज में गठित शारीरिक शोषण के प्रति जो कमेटी है उससे अवगत कराया।इस कार्यक्रम को सफल बनाने में युथ रेडक्रास, महिला प्रकोष्ठ और एनएसएस ईकाई के नोड़ल अधिकारियों के साथ सभी स्टाफ सदस्यों ने अपनी ने अपनी विशिष्ट भमिका निभाई।







Li pursuance to the Judgment of the Hon'ble Supreme Court of India dated \$ 5,2007 to Clini Apprel No. 887/2005, the UGC notated "Regulations on Curbing the Menate of Regulation related Educational Institutions, 2008. The Regulations are available on the URL website to specify to the URL website.

If it once again brought to your kind notice that ragging is a criminal offence and UtiC has framed regulations on curbing the menace of ragging in higher educational institutions in order to proceed, prevent and eliminate the scourge of ragging. These regulations are mandatory and all nest to one are required to take necessary steps for its implementation in total including the monitoring mechanisms and any violence of these regulations will be clewed seriously. If any institution tails to take adequate steps to prevent ragging or does not set in accordance with these Regulations or fails to provide perpetrators of locide its of ragging soutabily, it will across positive setters against itself by the UCC.

You are requested to step up authragging mechanism by way at adequate publicity shrough vertous mechanis; constitution of anti-ragging committee and anti-ragging squark, setting 12 of Anti-Ragging Cest, installing CCTV extrems at vital points. Anti-Ragging workshops, opdating all websites with node officers complete details, alarm betts etc. Regular increation and connecting with the students, identification of trouble-triggers and mention of Anti-ragging warrang in the installation's prespective and reformation booklets brockers shall be exacted. Supplies intraction of hostels with accommodation, contents, rest cum tecreations rooms, toilets, basestands and my other nearstreachish would augus well in preventing quelling ragging and any uncalled for behavior accident alarm by undertaken.

#### Preamble

The Govt. College Narnaul has framed and implemented the Policy against Sexual Harassment Rules in order to prevent and prohibit all forms of sexual harassment in the College campus and other connected places. Meanwhile, The M.D. University Rohtak has circulated the guidelines issued by University Grants Commission i.e. (Prevention, Prohibition and Redressal of Sexual Harassment of all sexes, men women &transgender and Students in Higher Educational Institutions) Regulations, 2015 which has come into force with effect from May 2, 2016 (Appendix). Under the above Regulations all Higher Educational Institutions including the College have to adopt and modify their existing rules in consonance with the above Regulations. Therefore, in compliance with the above Regulations, Govt. College Narnaul has framed the Govt. College Narnaul (Prevention, prohibition and redressal of sexual harassment of employees and students) Rules, 2016.

#### 1. Short title and commencement

- (a) These Rules may be called Govt. College for Women, Mahendergah(Prevention, prohibition and redressal of sexual harassment of employees and students) Rules, 2016.
- (b) They shall come into force immediately.

#### 2. Definitions:

In these Rules, unless the context otherwise requires: -

- (a) "Aggrieved party" means in relation to the work place, a person of any age whether employed or not, who alleges to have been subjected to any act of sexual harassment by the respondent;
- (b) "Act" means the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (14 of 2013);
- (c) "Campus" means the location or the land on which the College and its related institutional facilities like libraries, laboratories, lecture theatres, residences, halls, toilets, playground, parking areas, park-like settings and other amenities like sitting lawns, canteens, bank counter etc., are situated and also includes extended campus and covers within its scope places visited as a student of the College including transportation provided for the purpose of commuting to and from the College, the locations outside the College on field trips, study tours, excursions, short-term placements, places used for campus, cultural festivals, sports meets and such other activities where a person is participating in the capacity of an employee or student of the College.
- (d) "Commission" means the University Grants Commission established under Section 4 of the University Grants Commission Act, 1956 (3 of 1956);
- (e) "Covered individuals" are persons who are engaged in protected activity such as filing a sexual harassment charge, or who are closely associated with an individual who has engaged in protected activity and such person can be an employee or fellow student or guardian of the offended person;
- (f) "Employee" means a person as defined in the Act, and also includes, for the purpose of these Rules trainees, ITI apprentices (or called by any other name) interns, volunteers, lab attendant, laboratory assistants, whether employed or not, including those involved in field studies, projects, short-visits and college camps;
- (g) "Executive Authority" means the Principal of the College.
- (h) "Student Grievances/Sexual Harassment /Anti Ragging Committee". (SG/SH/ARC)" means Complaints Committee constituted under sub rule (1) of Rule 4 of these rules.
- (i) "Protected activity" includes reasonable opposition to a practice believed to violate sexual harassment laws on behalf of oneself or others such as participation in sexual harassment proceedings, cooperating with an internal investigation or alleged sexual harassment practices or acting as a witness in an investigation by an outside agency or litigation.
- (j) "Regulations" means University Grants Commission (Prevention, Prohibition and Redressal of Sexual Harassment of Women Employees and Students in Higher Educational Institutions) Regulations, 2015.
- (k) "Sexual harassment" means:
- (I) An unwanted conduct with sexual undertones if it occurs or which is persistent and which demeans, humiliates or creates a hostile and intimidating environment or is calculated to induce submission by actual or threatened adverse consequences and includes any one or more or all of the following unwelcome acts or behavior (whether directly or by implication), namely –
- Any unwelcome physical, verbal or non-verbal conduct of sexual nature;
- Demand or request for sexual favors;
- Making sexually colored remarks;

Property of State of

- Physical contacts and advances; or
- Showing pornography.
- (II) Any one (or more than one or all) of the following circumstances, if it occurs or is present in relation or connected with any behavior that has explicit or implicit sexual undertones -
- Implied or explicit promise of preferential treatment as quid pro quo for sexual favors;
- Implied or explicit threat of detrimental treatment in the conduct of work;
- Implied or explicit threat about the present or future status of the person concerned;
- Creating an intimidating offensive or hostile learning environment;
- Malicious intent, defined as a false allegation with the purpose of defaming or causing harm;
- Humiliating treatment likely to affect the health, safety dignity or physical integrity of the person concerned.
- (I) "Student" means a person duly admitted and pursuing a programme of study either through regular mode or distance mode, including short-term training programme in the College Provided that a student who is in the process of taking admission in the College's campus, although not yet admitted, shall be treated, for the purposes of these rules, as a student of the College when any incident of sexual harassment takes place against such student in the College. Provided that a student who is a participant in any of the activities in the College though enrolled in another College as a student shall be treated, for the purpose of these Rules, as a student of the College when any incident of sexual harassment takes place against such student in the College.
- (m) "Third Party Harassment" refers to a situation where sexual harassment occurs as a result of an act or omission by any third party or outsider, who is not an employee or a student of the College, but a visitor to the College in some other capacity or for some other purpose or reason;
- (n) "The College" means Government College Narnaul.
- (o) "Victimization" means any unfavorable treatment meted out to a person with an implicit or explicit intention to obtain sexual favor;
- (p) "Work place" means the campus of the College including:
- Any department, office, branch or unit which is established, owned, controlled or wholly or substantially financed by funds provided directly or indirectly by the College;
- Any sports ground, sports complex or competition or game venue, whether residential or not used for training, sports or other activities relating to the College
- any place visited by the employee or student arising out of or during the course of employment or study including transportation provided by the College Authority for undertaking such journey for study in the College.
- (q) "Retaliation" means engaging in conduct that may reasonably be perceived to:
- Adversely affect a person's educational, living or work environment because of their participation in the reporting and investigation of a violation; or
- Actively discourage or coerce a person from making a report or participating in an investigation under the rules.
- 3. Responsibilities of the College:

The responsibilities of the College shall be as prescribed under the Regulation No. 3 of the Regulations.

Grievance Support mechanism:

The Principal shall nominate a Support Group, which will meet both complainants and respondents in an informal manner to give clarifications or advice on the course of action open to them in matters pertaining to sexual harassment. However, the advice or clarifications the Support Group may give will not be binding either on the complainant, respondent. The Support Group shall be made up of convener women cell, two senior Professors (one male and one female) and two students' representative (one male and one female) from UG classes.

The Principal may also recommend an ex-student as member of the Support Group. The Support Group will be familiar with SG/SH/ARC guidelines and a working knowledge of the legal framework in which these guidelines operate. Provided that framing the complaint and formally registering it will be the individual's own responsibility as will be the respondent's written reply to a complaint made against them. Provided that there is no obligation to consult the Support Group and a complaint can be lodged directly with SG/SH/ARC without first consulting a member of the Support Group. The same applies to respondents who wish to bypass the Support Group and reply directly to the SG/SH/ARC. The Support Group cannot be called as witness in any hearing of the SG/SH/ARC.

## 5. Grievance Redressal Mechanism:

- (1) The Principal/Senior Professor of the college will be Convener of the Student Grievances/Sexual Harassment/Anti Ragging Committee"(SG/SH/ARC). The SG/SH/ARC shall have the following composition:
- There shall be representation of woman faculty members as members of the committee. Provided that in case a senior level woman employee is not available, the members shall be nominated from any other college in the vicinity as referred to in sub-section 2 (o) of the Act.
- two faculty members and two non-teaching employees, preferably committed to the cause of women or who have had experience in social work or have legal knowledge, selected by the faculty and by non-teaching employees respectively;
- Two students, if the matter involves students, who shall be enrolled at the graduate levels, selected through transparent and democratic procedure.
- (2) At least one-half of the total members of the)(SG/SH/ARC shall be women.
- (3) The term of office of the members of the (SG/SH/ARC) will be for a period of three years. Provided one-third of the members of (SG/SH/ARC) may change every year.
- (4) The Member appointed from amongst the non-governmental organizations or associations shall be paid such fees or allowances for holding the proceedings of the (SG/SH/ARC)...
- (5) Where the Convener or any member of the (SG/SH/ARC)
- Contravenes provisions of Section 16 of the Act; or
- Has been convicted for an offence or an inquiry into an offence under any law for the time being in force is pending against them; or
- Has been found guilty in any disciplinary proceedings or a disciplinary proceeding is pending against them; or
- has so abused their position as to render their continuance in office prejudicial to the public interest, Such Member, as the case may be, shall be removed from (SG/SH/ARC) and the vacancy so created or any casual vacancy shall be filled by fresh nomination in accordance with the provisions of this Rule.

- 6. Responsibilities of Student Grievances/Sexual Harassment /Anti Ragging Committee(SG/SH/ARC) The SG/SH/ARC shall:
- Provide assistance if an employee or a student chooses to file a complaint with the police;
- Provide mechanisms of dispute redressal and dialogue to anticipate and address issues through just and fair conciliation without undermining complainant's rights, and minimize the need for purely punitive approaches that lead to further resentment, alienation or violence;
- Protect the safety of the complainant by not divulging the person's identity, and provide the mandatory relief by way
  of sanctioned leave or relaxation of attendance requirement or transfer to another department or supervisor as
  required during the pendency of the complaint, or also provide for the transfer of the offender;
- Ensure that victims or witnesses are not victimized or discriminated against while dealing with complaints of sexual harassment; and
- Ensure prohibition of retaliation or adverse action against a covered individual because the employee or the student is engaged in protected activity.

The jurisdiction of the SG/SH/ARC will be restricted to instances of offences in the nature of sexual harassment and not against infractions of any other rules.

## 7. The process for making complaint and conducting Inquiry: -

The SG/SH/ARC shall comply with the procedure prescribed in these Rule and the Act, for making a complaint and inquiring into the complaint in a time bound manner. The College shall provide all necessary facilities to the SG/SH/ARC to conduct the inquiry expeditiously and with required privacy.

## 8. Process of making complaint of sexual harassment: -

(1) An aggrieved person shall submit a written complaint to the SG/SH/ARC within three months from the date of the incident and in case of a series of incidents within a period of three months from the last incident.

The email address for such complaints is principal.gcnnl@gmail.com

Provided that where such complaint cannot be made in writing, the Presiding Officer or any Member of the SG/SH/ARC shall render all reasonable assistance to the person for making the complaint in writing;

Provided further that the SG/SH/ARC may, for reasons to be accorded in the writing, extend the time limit not exceeding three months, if it is satisfied that the circumstances were such which prevented the person from filing a complaint within the said period.

(2) Friends, relatives, colleagues, co-students, psychologist, or any other associate of the victim may file the complaint in situations where the aggrieved person is unable to make a complaint on account of physical or mental incapacity or death.

#### 9. Process of conducting inquiry: -

- (1) The SG/SH/ARC shall, upon receipt of the complaint, send one copy of the complaint to the respondent within a period of seven days of such receipt.
- (2) Upon receipt of the copy of the complaint, the respondent shall file his or her reply to the complaint along with the list of documents, and names and addresses of witnesses within a period of ten days.

- (3) The inquiry has to be completed within a period of ninety days from the receipt of the complaint. The inquiry report, with recommendations, if any, has to be submitted within ten days from the completion of the inquiry to the Executive Authority of the College. Copy of the findings or recommendations shall also be served on both parties to the complaint.

  (4) The Executive Authority of the College shall act on the recommendations of the SG/SH/ARC within a period of thirty days from the receipt of the inquiry report, unless an appeal against the finding is filed within that time by either party.

  (5) An appeal against the findings or/recommendations of the SG/SH/ARC may be filed by either party before the
- (6) If the Executive Authority of the College decides not to act as per the recommendations of the SG/SH/ARC, then it shall record written reasons for the same to be conveyed to SG/SH/ARC and both the parties to the proceedings. If on the other hand it is decided to act as per the recommendations of the SG/SH/ARC, then a show cause notice, answerable within ten days, shall be served on the party against whom action is decided to be taken. The Executive Authority of the College shall proceed only after considering the reply or hearing the aggrieved person.

Executive Authority of the College within a period of thirty days from the date of the recommendations.

- (7) The aggrieved party may seek conciliation in order to settle the matter. No monetary settlement should be made as a basis of conciliation. The College shall facilitate a conciliation process through SG/SH/ARC, as the case may be, once it is sought. The resolution of the conflict to the full satisfaction of the aggrieved party wherever possible, is preferred to purely punitive intervention.
- (8) The identities of the aggrieved party or victim or the witnesses or the offender shall not be made public or kept in the public domain.

#### 10. Interim redressal: -

The College may,

- Transfer the complainant or the respondent to another section or department to minimize the risks involved in contact or interaction, if such a recommendation is made by the SG/SH/ARC;
- Grant leave to the aggrieved with full protection of status and benefits for a period up to three months;
- Restrain the respondent from reporting on or evaluating the work or performance or tests or examinations of the complainant;
- Ensure that offenders are warned to keep a distance from the aggrieved, and wherever necessary, if there is a definite threat; restrain their entry into campus;
- Take strict measures to provide a conducive environment of safety and protection to the complainant against retaliation and victimization as a consequence of making a complaint of sexual harassment.

#### 11. Punishment and compensation:

- (1) Anyone found guilty of sexual harassment shall be punished in accordance with the rules of the College, if the offender is an employee.

(2) Where the respondent is a student, depending upon the severity of the offence, the College may -

- Withhold privileges of the student such as access to library, classrooms,, scholarships, allowances, and identity cards;
- Suspend or restrict entry into campus for a specific period;
- Expel and strike off name from the rolls of the institution, including denial of readmission, if the offence so warrants;

Award reformative punishments like mandatory counseling and/ or, performance of community services. If the respondent is a repeated offender, the College shall take cognizance of this in deciding on the nature and quantum of punishment.

- (3) The aggrieved person is entitled to the payment of compensation. The College shall issue direction for payment of compensation recommended by the SG/SH/ARC which shall be recovered from the offender. The compensation payable shall be determined on the basis of -
- Mental trauma, pain, suffering and distress caused to the aggrieved person;
- The loss of career opportunity due to the incident of sexual harassment;
- The medical expenses incurred by the victim for physical, psychiatric treatment;
- The income and status of the alleged perpetrator and victim; and
- The feasibility of such payment in lump sum or in installments.

## 12. Action against frivolous complaint: -

If the SG/SH/ARC concludes that the allegations made were false, malicious or the complaint was made knowing it to be untrue, or forged or misleading information has been provided during the inquiry, the complainant shall be liable to be punished as per the provisions of sub-rule (1) of rule 10, if the complainant is an employee and as per sub-rule (2) of that Rule, if the complainant is a student. However, the mere inability to substantiate a complaint or provide adequate proof will not attract attention against the complainant. Malicious intent on the part of the complainant shall not be established without an inquiry, in accordance with the procedure prescribed, conducted before any action is recommended.

These Rules may be revised and amended from time to time on the basis of court judgments and revision in other applicable laws, rules and regulations. Rules may also be amended through feedback and suggestions from members of Government College Narnaul As and when amendments are made.

## Repeals and savings:

- (1) The existing Govt. College Narnaul policy against Sexual Harassment Rules is hereby repealed.
- (2). In spite of such repeal any action already initiated and punishment imposed under the repealed rules shall be valid.


